The Murray, Nebraska Board of Trustees met for the purpose of holding a public hearing for the One and Six Year Road and Street Plan on Tuesday, September 12, 2023, at 7:00 pm in the Murray Municipal Building. Present: Trustees: Jeff Anderson, George Blessing, Stan Flak, Don Strong; Village Clerk Shelli Hayes, Maintenance Operators Jerome Speck and Ben Moore, Village Attorney Roger Johnson; and guests.

Notice of the meeting was given in advance thereof by posting in (3) three public places on August 31, 2023, as shown by the certificate attached to these minutes, and published in the Omaha World Herald Notice Section on Friday, September 1, 2023. Notice of the meeting was simultaneously given to the Chairman and all members of the Board of Trustees. Their acknowledgement of receipt of notice and agenda is attached to these minutes. All proceedings thereafter were taken while the convened meeting was open to the attendance of the public.

Chairman Anderson called the meeting to order at 7:00 PM, and roll call was conducted. Anderson informed the audience of the location of the Open Meetings Act poster.

Chairman Anderson advised the public that a three (3) minute time allotment would be given to each and every person who would like to address the board.

Chairman Anderson opened the hearing for the One and Six Year Road and Street Plan at 7:01 pm.

Hearing no public comment, Chairman Anderson closed the hearing at 7:02 pm.

Motion by Strong, seconded by Anderson to adopt Resolution 23-12, One and Six Year Road and Street Plan 2023/2024 through 2028/2029; ayes: Blessing, Flak, Strong, Anderson; motion carried.

Motion by Flak, seconded by Anderson to adopt Resolution 23-09, Municipal Annual Certification of Program Compliance to Nebraska Board of Public Roads Classifications and Standards 2023; ayes: Blessing, Flak, Strong, Anderson; motion carried.

With no further business, Chairman Anderson adjourned the meeting at 7:03 pm.
