Motion by Blessing, seconded by Kucera to approve bid from A-1 Locksmith for \$2,838.00 for electronic timer locks for two restrooms at Young Park; ayes: Blessing, Strong, Kucera, Anderson; nays: Flak; motion carried.

Trustee Flak stated regarding a property near Young Park, he, the village clerk, and the owner, Mr. Lamare St Clair, participated in an appeal hearing concerning grass height at the property identified. Flak advised he would find that the grasses are over twelve inches, and that the height violates village ordinance 130.06. Flak advised his ruling from the hearing would be that the grasses were in violation and the property would need to be mowed.
