### Utilities

Our Utility Bill covers: Water, Sewer, Trash Pickup  
\$300.00 deposit required; returned after 2 years of satisfactory payment history  
For Monthly Payment: Sign Up for AutoPay or Pay Online at <http://ne.gov/go/murrayvillagene>  
Or pay by mail, in person, or dropbox; Cash, Check, Credit Card

#### Water:

- A flat fee for water is charged per household per month (\$20.00)  
Plus \$5.50 per thousand gallons of usage
- Meters are read between 25<sup>th</sup> & 29<sup>th</sup> of the month, and billing is a mailed postcard.
- Payment is due before or on the 10<sup>th</sup> of each month. Payments are considered late, with a \$15 late fee at the end of the business day immediately following the 10<sup>th</sup>.
- Customers can sign up for automatic bank withdrawal for monthly utility bill payment.
- Late notices will be mailed advising what date service will be discontinued for unpaid bills.
- \$80.00 reconnection fee will be assessed to establish service after payment in full.
- \$20.00 fee will be assessed for insufficient or returned checks.

#### Sewer:

- A flat fee for sewer is charged per household per month (\$69.21-residential) (\$78.35-business)

#### Trash:

- 1 Black can (trash) & 1 Green Can (recycling) (\$16.64)  
Add extra trash can for \$1.63 per month (Call Clerk to request)
- Pickup is every Monday – Cans should be on curb no later than 6:00 am
- Any week containing a holiday, trash pickup the following day
- If your trash didn't get picked up, call Papillion Sanitation 402-346-7800 (if you call that day, they will typically be able to come back out to pick up)

- Dogs and Cats must be licensed with the village by May 1<sup>st</sup> every year
- Copy of Rabies Vaccination certificate must be provided
- Fees: Altered Animals \$11.25; Unaltered Animals \$26.25;
- Kennel License required for more than 3 dogs in a household \$40.00
